

Job Title: Student Discipline Compliance Specialist

Supervisor: Program Administrator for Student Conduct and Discipline Pay Grade: 31 Contract Length: 245 Days

## Job Summary

Position is responsible for providing compliance support and technical support to the Program Administrator for Student Conduct and Discipline and subsequent department.

# **Essential Duties**

- 1. Performs a variety of activities for supervisor and assigned staff such as composing replies to correspondence on own initiative, responding to inquiries from a variety of sources, summarizing reports and information to facilitate review by superior and investigating, evaluating and resolving problems within scope of position.
- 2. Researches, summarizes and analyzes information; and compiles data to prepare special and recurring reports containing specialized or sensitive information following general direction of supervisor or assigned staff; selects relevant information from a variety of sources.
- 3. Prepares or directs preparation of minutes, notices, manuals, agendas and correspondence with all support documentation, requiring application of a specialized knowledge of the assigned function.
- 4. Maintains and tracks budgets for department; monitors expenditures and performs analysis on accounts; prepares both special and recurring reports for supervisor or assigned staff.
- 5. Stays abreast of current regulations and procedures related to student discipline; including the Student Behavior and Administrative Response Collection (SBAR), regulations and applicable local guidelines.
- 6. Assists School Leadership, and building administrators to help ensure compliance with local, state, and federal laws, regulation, and procedures for student discipline and community charges.
- 7. Supervises and coordinates the preparation of student discipline review documents as required by School Board policy.
- 8. Conducts ongoing monitoring of complaint paperwork division wide, including ensuring that Administrative Discipline Hearings are properly documented following local, state and federal procedures and regulations. Audits discipline files and addresses the areas of non-compliance.
- 9. Provides one-on-one and group training sessions for building administrators on compliance, and procedural issues.
- 10. Provides technical assistance and troubleshoots software and hardware problems associated with the data entry and document generation for student discipline records.
- 11. Meets with Student Information Systems team to develop procedures and suggest program modifications and/or improvements.
- 12. Edit and update NNPS Rights and Responsibilities Handbook and prepares it for annual publications, including translation.
- 13. Conferences with parents/guardians of students concerning discipline, alternative placement, and community charges.
- 14. Arrange travel accommodations and conference registration.
- 15. Maintains a high level of confidentiality
- 16. Performs other such duties as may be required.
- 17. Models non-discriminatory practices in activities.

## Minimum Qualifications (Knowledge, Skills and/or Abilities Required)

Associate's degree in Business or other related field or any equivalent combination of experience, training and education. Must possess knowledge of executive level support service management and be able to work under minimal supervision. Must have ability to exercise professional decorum. Must possess excellent organizational skills and the ability to handle details accurately. Ability to work effectively and maintain composure under pressure of short deadlines. Proficient in filing and documentation management, electronic and paper-based. Mustdevelop and maintain a strong knowledge base in School Safety and Discipline law, due process, programs, services, best practices, and other related areas. Must maintain knowledge of current and evolving law and practices. Must possess the ability to establish and maintain effective working relationships.

#### **Working Conditions & Physical Requirements**

The physical demands described here are representative of those that must be met by an employee to successfullyperform the essential functions of this job.
